### **Old business:**

#### a. Transportation:

Mr. Sonza – Transportation is officially up and going. Mr. Sonza shared a summary of the transportation options available. Another option will be available once the VSC has acquired vans. Bids for vans will begin. President Wilson question on where the van(s) would be parked if acquired this year. Commissioner Sonza stated that is something that will need to be investigated. Once a van has been ordered.

#### b. Dental Services

Mr. Sonza is working on adding this to the financial assistance policy & procedures manual. Stating there must be a financial assistance application done and the applicant must meet the financial need qualification. A cap of \$600.00 for bi-annual cleanings, x-ray, and exam is implemented for this service. It will be a direct pay to the vendor. A copy of \$2,500.00 for emergency dental services. No cosmetic procedures, dentures, implants, etc.

### c. Eyecare Services

Mr. Sonza introduced Eyecare Services to the board. Eye exam and glasses not to exceed \$1,000.00, no special addons example: no line bi-focal or polarized lenses etc. Stating there must be a financial assistance application done and the applicant must meet the financial need qualifications.

Motion to adopt Eyeglass services was made by Mr. Rowland, duly seconded by Mr. Watson

#### Discussion:

President Wilson stated the Veteran needs to enroll at the VA medical first and see what they may be eligible for first before we consider assistance with paying for glasses.

Motion amended to adopt Eyeglasses services with the stipulation the Veteran must enroll at the VA medical center first to see if they are eligible there prior to applying at the VSC made by Mr. Rowland, seconded by Mr. Watson.

## a. Policies & Procedures Manual

#### b. Direct Vendor Payment System

The Direct Vendor payment system is up and moving. Direct payments will now be made to the landlord/mortgage company, duke (electric & gas), water company or any other necessary vendor for utilities.

Applicants will only receive a check for food, hygiene, clothing, ID's, and possibly a couple of other items that will be determined on a case-by-case basis.

#### c. Email Newsletter

Emailing Newsletter cost range is \$1470.00 to \$1795.00 a year. Newsletter will be set up by the webmaster.

#### d. Remaining FY24 Advertising Budget

VSC will consider doing advertising with iHeart throughout the Cincinnati Bengals football season if the contract can be amended to no more than \$8000.00. Executive Director will handle the negotiations with WLW.

#### **Discussion:**

Commissioner Wilson had a question about possibly working with some of the other counties with the advertising. Doing a joint advertising to free up funds for the purchase of vans, stating vans are top priority to her. Director Sonza stated this is something he will look into. Most have already committed their advertising budget for 2024 but, 2025 maybe a possibility to work together on Advertising.

Commission Watson discussed getting monies from the state budget to do advertising for the districts. This will benefit the state as well. Motion to approve the \$8000.00 cap for IHeart was made by Mr. Rowland, duly seconded by Mr. Watson.

President Wilson, I would like to put on record that now that we have and Executive Director, I feel he should be the one reaching out and finding the advertising opportunities. If a member of the board has a thought about advertising this should be given to the Director for him to negotiate the contract and be able to handle all the legal side of things prior to bringing to the board.
