Motion made by Mr. Rowland in light of recent and past events, especially the most recent event on January 13, 2025, which brough embarrassment to this commission I move that we recommend to the Court of Common Pleas Commissioner Steven Staniford because of his outrageous, unprofessional and unethical conduct that he be removed immediately, duly seconded by Mr. Watson.

Discussion:

Mr. Staniford to Mr. Rowland – I'm glad you were able to comment on the event based on the source of the information you received, I appreciate that

Mr. Burwinkel states he was there and saw this firsthand. I'm urging this board and the public to ask the courts to make a swift decisive decision to remove Mr. Staniford. Standards of public service must be upheld, disrupting self-serving behavior which we saw right here at this meeting cannot be allowed to serve as a critical point of the body. This serves as a turning point, we must send a message that the Veterans Service Commission is here to serve, restore, accountability and transparency for the veterans of Hamilton County.

Mr. Watson – I've served with Mr. Staniford on this board for a year now and the recent event is only one of 20 or 30 occasions where he has attacked people, been disruptive and cursed at people during a board meeting myself included. His behavior when someone opposes or doesn't support his mission/goal he attacks you, it doesn't matter who it is, or if someone else may have a better idea, he first response is to attack that person. He has no respect or little respect for anyone or their thoughts. I have observed a lot of his behavior and been a target of his behavior for a year now. This is nothing new.

Mr. Sonza – I was there, I serve at the pleasure of this board, the board has the authority when it comes together no one individual has authority to speak on the behalf of the board. I have spoken with each of you individually and all agree that the board makes decisions not an individual member. What happened that Monday at West Point and the US Army, the term would be Conduct Unbecoming as a commissioned or even a noncommissioned officer. What happened was very unbecoming of this board with clients in the lobby and in the office with service officers seeing sheriffs' deputies come in to deal with a commissioner's behavior. I have done my best to work with Mr. Staniford in the 7 months that I have been here we've agreed at times and disagreed at times but, the shear display unprofessional outrageous behavior in front of clients and staff, two of them who had never encounter a commissioner until that date. I have updated the staff with the concerns, they have expressed their concerns with me and President Wilson has been informed of the concerns of the staff.

Mr. Headen – I've worked with Staniford since I've been here, he is a very smart young man but, I was called on 1-13 and it was very disturbing, and I came to the office, spoke with the magistrate who was here. As a board member I have no right to come into any office and tell anyone what to do, period. In this meeting as a board, we can do that, we can direct, make decisions etc. but no individual member can instruct anyone in this office to do anything. When I arrived Mr. Staniford calmed down some, I can't attest what I heard just what I saw when I arrived. I have seen behavior on this board that I disagree with. I'm here for two reasons: to work with this board and to fight for veterans, that's my mission should be all our missions. He is the director he needs to run the day-to-day operations. If there is an issue that needs to be discussed or addressed that must be done here as a board. I support board members, but I don't support the misbehavior of a board member. That's all I have to say

Mr. Staniford – stated he never raised his voice; he stated that the meeting could be held in the boardroom and when the magistrate, deputies, and other subordinates came out he was sitting in the boardroom sitting. Yes, that is your private office, this office was given by the County Commissioners. So, this is the office of the Commission. Mr. Sonza is the reason things escalated, he's the one who contacted the deputies and involved other subordinates in this. He stated that no one even knew he was in the office until things escalated. Mr. Sonza's judgement is what is questioned here. Mr. Sonza reached out to a person he oversees, who is being investigated instead of reaching out to the board. The only thing he gives is a (bleep) about pardon, my language, I don't care about politics, I'm not a politician, I care about Veterans. Nobody here that knows me can deny that. Do you think I'm going to give up watching this commission whether I'm on this board or not. No because it was a mess when I got here and I'm damn sure not going to make sure it's a mess if I'm not here. It's as simple as that, when I have a commissioner that states she got clearance through the Ohio Ethics Commission to be on this board and when I asked, I'm told she never got clearance to be on this commission, and she tells me I can stick it up my (bleep). I record these meetings, so I can play it back if you would like.

Mr. Sonza provided an update on the Dole Act Law that was signed by President Biden on January 2, 2025.

The section pertaining to County Veteran Service Officers, to allow10 million dollars in federal funds annually for two years. To create new programs, support or expand similar entities with areas of High Suicide Rates through the crisis line and critical care. An inquiry has been submitted to the state for more information on this law for clarification on how to pursue this grant.

Mr. Burwinkel asked what avenue the VSC takes to get grants. Mr. Sonza as of now only the Addiction Response Grant has been considered. But we work with our budget analyst Cheryl Floyd for directions on any grant monies available.
